## MOTOR SPORTS CAN BE DANGEROUS AND MAY INVOLVE INJURY YOU MUST READ AND AGREE TO THE FOLLOWING DECLARATION BELOW WHICH IS DESIGNED TO CREATE A LEGALLY BINDING RELATIONSHIP IN RETURN FOR YOUR BEING ALLOWED TO PARTICIPATE\*

a) I will satisfy myself (by sighting lap or otherwise) before taking part that the venue and track is acceptable to me with regards to its features and physical layout.

b) By taking part I accept the risks involved including the risks of injury.

c) I declare that I am competent to take part and am aged 9 or above.

d) I am aware and accept that other participants will be on the course at the same time.

e) I am free of alcohol and drugs (prescribed or otherwise) and undertake not to consume any substances during or prior to any event that will impair my ability to take part.

f) I have read, understood and will comply with all circuit instructions, regulations and final instructions for this event given by the organiser and understand any reckless/dangerous driving is strictly forbidden and will result in my immediate dismissal from the event.

g) This is a public event where participants may be photographed. These images may be used by Greenpower Education Trust. If you would not like to be photographed, please make us aware using the form below.

h) I have seen and understood the briefings that have been sent to me prior to this event. I understand that failure to comply with these procedures could result in disqualification.

I) I agree to comply with all requirements imposed by Greenpower Education Trust in relation to COVID-19. Any breach of these requirements may result in being disqualified from the event.

j) I am not, neither is any person connected with my entry nominated to attend the event currently experiencing any symptoms of COVID-19 and have not done so for 14 days. I have not, neither has any person connected with my entry knowingly been in contact with anyone showing symptoms within the last 14 days, except as a healthcare professional. If after submitting this form I, or any person connected with my entry knowingly come into contact (except as a healthcare professional) with someone with COVID-19 or if I, or any person connected with my entry start to exhibit any of the signs indicating that they may be infected I will immediately withdraw from the Event together with all persons connected with my entry, notify Greenpower and ensure that my close contacts also do not attend. Should I, or any person connected with my entry become ill at or start to exhibit COVID-19 symptoms at the Event I shall withdraw safely and notify the Greenpower Secretary of the Meeting by telephone / SMS accordingly including identification of those others who I have come into contact with at the Event. In addition, I confirm that the symptomatic person will as soon as practicable contact the NHS for the purposes of test and trace. If I or any person connected with my entry have knowingly contracted COVID-19 I declare that I have been symptom free for at least 14 days and am physically fit to compete with no new medical problems that may affect my ability to safely operate a motor vehicle in competition.
